Introduction

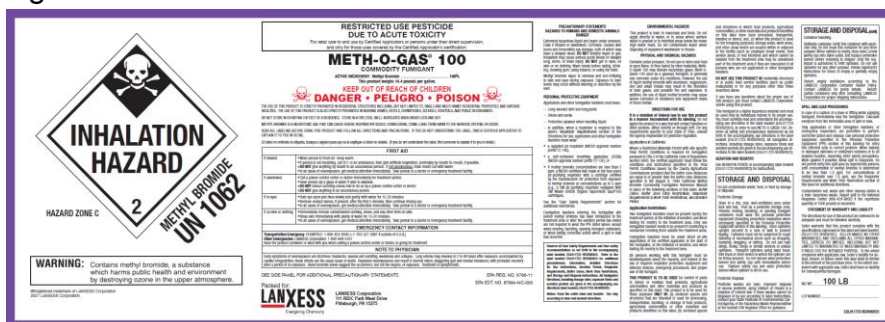

In order to purchase and use Meth-O-Gas fumigants, a state-certified pesticide applicator must complete a training program specific to the safe handling and use of these products. Successful completion of the LANXESS Meth-O-Gas Applicator Education Program will allow an applicator with a valid state pesticide applicator license to purchase and use Meth-O-Gas for a period of two years.

This **User Guide** is designed to help new and existing users navigate the LANXESS Meth-O-Gas Applicator Education Program training website found at: <https://www.fumigantstrainingsite.com>.

After registering with the website, you will be given access to training materials and will have three attempts to pass the Certification Test with a minimum score of 80%. After passing the test, you will be provided with a Certificate of Completion to prove that you successfully completed your training. This certificate can be downloaded at any time from your homepage. Present your certificate, along with your valid state-certified applicator license, to your Meth-O-Gas supplier when placing an order. Your certificate will be valid for a period of two years.

Welcome to the Meth-O-Gas Applicator Education Program hosted by LANXESS Corporation.

This program provides information about the safe handling and use of our methyl bromide fumigants, Meth-O-Gas 100 and Meth-O-Gas Q. In addition to becoming a state-certified pesticide applicator, you must complete a methyl bromide fumigant training program before you are approved to purchase and use these products. LANXESS provides this training program as one option to help you meet this requirement.

Our training materials will educate you on the hazards of methyl bromide and how to use these fumigants properly in accordance with product labels. To complete the Meth-O-Gas Applicator Education Program, you must pass our applicator exam with a minimum score of 80%. After passing the exam, you will be issued a Certificate of Completion to present to your Meth-O-Gas supplier, valid for two years. Maintaining a valid state applicator license and training certificate will allow you to continue purchasing and using Meth-O-Gas fumigants.

Completing Your Trainee Profile

1. For new users, once your account has been registered, you will be redirected to the Profile page. **You must complete all fields in your trainee profile.** Enter your information as accurately as possible. While you may edit this at a later date, your First Name, Last Name and Company Name will appear on your Certificate of Completion **exactly as you have entered them for the first time.**

2. After you have completed your trainee profile, click **Save Changes**. If all required information has been entered, you will see a confirmation message. If not, you will be asked to complete any empty fields.

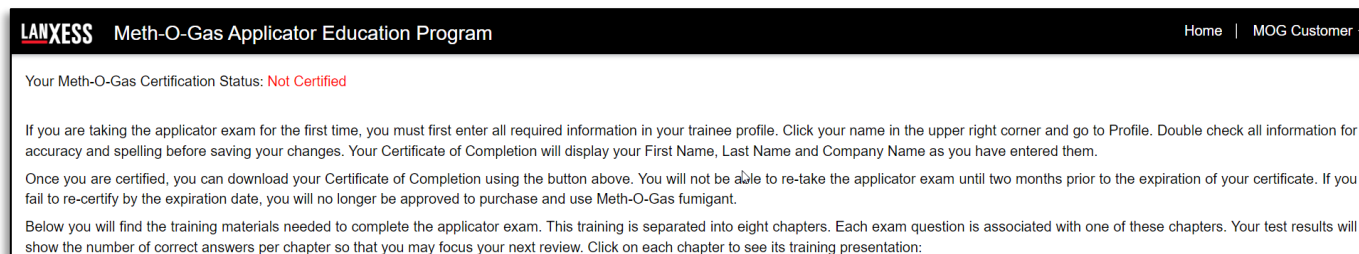

Until then, you will not be able to access training materials or take the Certification Test.

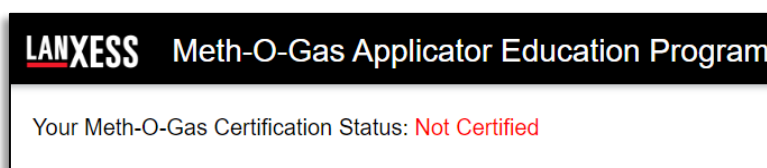

Completing Your Meth-O-Gas Training

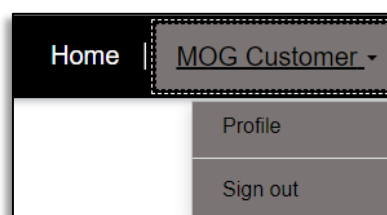
1. After your account has been activated, you will be able to view the instructions and training documents on your Home page. Click the link to the **Fumigation Training Guide** to download a PDF copy. The training guide and Meth-O-Gas product labels will be your training materials for the LANXESS Meth-O-Gas Applicator Education Program. Carefully review these materials before attempting to complete the Certification Test, as you will only be given three attempts to achieve a minimum passing score of 80% (at least 40 out of 50 correct answers).



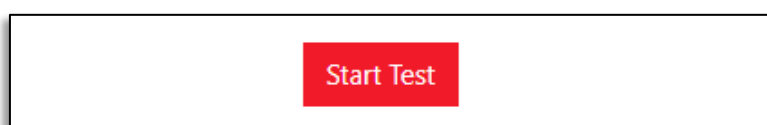
2. Your Certification Status is shown at the top of your Home page.



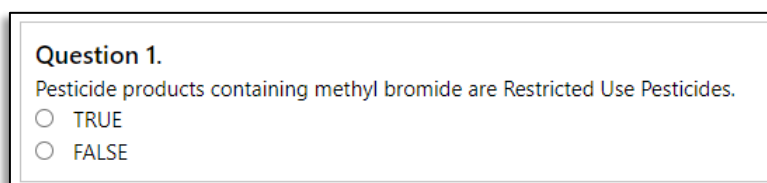
3. You can navigate to your Home page or Profile page, or sign out of the training website, using the menu options in the upper right corner of the menu bar.



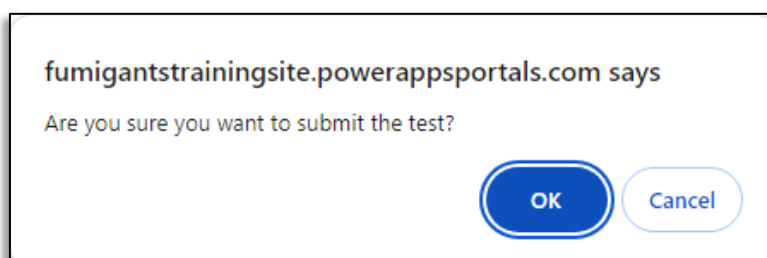
4. Click **Start Test** on the Home page when you are ready to complete the Certification Test.



5. Complete all 50 multiple-choice test questions and click **Submit** at the end of the test. You will be prompted to answer any questions you may have missed.



6. Click **OK** to verify the submission of your Certification Test.



7. After submitting your test, you will be redirected to the Exam Results page. Here, you will see your overall test score as well as the individual scores for each of the sections in the Fumigation Training Guide. If you passed the Certification Test, you can download your Certificate of Completion by clicking **Download Certificate**. Congratulations, you have now successfully completed the LANXESS Meth-O-Gas Applicator Education Program. Click **Exit** to log out of the website.

Successful completion of the Meth-O-Gas Applicator Education Program allows you to purchase Meth-O-Gas products for the next two (2) years as long as you maintain a current and applicable US state pesticide applicator license.

Click on the "Download Certificate" button to download the certificate.

Present this certificate to your Meth-O-Gas supplier as proof of completing the Applicator Education Program. You can renew this training certificate before the two-year period expires by logging in and retaking the exam.

8. If you did not pass the Certification Test, you will have two additional opportunities to retake it. Navigate back to your Home page and click **Start Test** to begin your next attempt. If you fail all three attempts, you will not become certified to use LANXESS Meth-O-Gas fumigants.

Exam Result: Failed

A passing score is 80% or greater (at least 40 correct answers out of 50 questions). Unfortunately, your score is 30% (15 out of 50) and you did not meet the requirements to earn a certificate of completion. Below are the results of each section:

You will be allowed to retake the training exam up to a maximum of three (3) times. Please review the Meth-O-Gas Applicator Education Program training materials and the exam results above to determine which topics might need your additional focus before retaking the exam. You must pass this exam to qualify for the use of Meth-O-Gas fumigants.

If this is your third unsuccessful attempt, you will not be allowed to retake the test. Please contact your supplier for more information.

Downloading Your Certificate of Completion

1. After passing the Certification Test, your Certification Status will be updated on your Home page.

2. You may retake the Certification Test, and become re-certified to purchase and use Meth-O-Gas, starting one month prior to the expiration date on your Certificate of Completion. If you attempt to retake the test before then, you will receive an error message.

3. You can download a copy of your Certificate of Completion at any time by clicking **Download Certificate** on your Home page.

4. Your Certificate of Completion will display the First Name, Last Name, and Company Name that you entered into your trainee profile when first registering with the site. Present this certificate to your Meth-O-Gas supplier as evidence that you have completed your required Meth-O-Gas training.
